### Membership

Our 2018/2019's membership again stood at virtually 100% of the property owners on Grand Lake and Green Lake, a statistic that makes the envy of other lakes in Val-des-Monts. It also gives us a strong voice when we need to interact with various levels of government. This past year, 67 members also signed up for Winter Patrol. We want to thank James Lévesque, our patroller for performing this important and historically successful patrol service.

We continue to work towards increasing the size of our reserve funds to maintain their purchasing power.

### **Treasury**

Our treasury continues to reflect a strong surplus position, with reserves of \$63,195 invested securely and conservatively in CDIC-insured instruments plus a current account balance of just over \$600. As usual, our annual fees cover all administrative costs, which are minor, and all Association events are designed to be self-financing. In fact, some events actually contribute funds to the Association.

As most of you are aware, the Association maintains the reserve funds largely for contingencies and unexpected events that could arise and potentially impact our Members. Certain reserves are also earmarked for specific purposes.

We believe that it is prudent to continually seek means of increasing reserves creatively to allow us to be in a position make meaningful contribution to any significant problem that may surface, as well as provide critical funding to spending initiatives that could be brought to us by members to maintain, protect or enhance the lake environment and water quality we all cherish. A guiding principle for reserve spending is that the result will benefit all members. Our 2018/2019 Milfoil Project is virtually complete, at a cost of approximately \$6,000.

# **Grand Lake/Lac Grand**

#### **Environment**

#### General

Grand Lake is a member of the Federation of Lakes of Val-des-Monts. The Federation has put forward its most ambitious project to date for the protection and improvement of lake water quality in the Val-des-Monts area. The Val-des-MontsIntegrated Watershed Management Project (PGLVDM) is a study of all the accessible and inhabited lakes of the Rivière Blanche watershed in Val-des-Monts with a view to create a Water Master Plan (PDE).

This would see the Federation participating with VdesM to develop an action plan to seek proper funding (from various levels of government) and then implement actual plans that will help us protect our watershed.

This process will inevitably be slower than we want, but at least it is starting. We, as the GLA, are supporting this cause and the Federation's role.

#### **Water Testing**

2019 is the 16th year we have tested the waters for Tp (Total phosphorous), the principal indicator for the nutrient level in the lake, which promotes weed growth.

When we began in 2003, the advice from the biologist was that we should not put too much stock into actual numbers for any particular year because of the many variables that could affect the results; but if we collected data on a continuing basis, that there would be trends that would be revealed.

For the number crunchers in the membership, we shall post all results on the website with GPS coordinates that identify a more precise location of the 5 current test sites. We will do the same with fecal coliform testing results.

Later in the summer we will test for e-coli. This is done to reassure us that the lake is safe for swimming which has far and away been the case every summer we have tested.



This is what Eurasian Milfoil looks likeplease remove carefully any floating pieces you see! If not, they eventually sink to the lake bottom and multiply like rabbits.

## **Boating and Swimming Safety**

EVERYONE who operates a motorized pleasure water craft (PWC) must carry on board at all times a proof of competency (such as a Pleasure Craft Operator Card, a Boating Safety Course Completion Card, proof of the successful completion of a boating safety course, or a certificate or other document pertaining to boating safety). Proof of competency is not required for pleasure craft without motors. Visit <a href="www.boatingsafety.gc.ca">www.boatingsafety.gc.ca</a> to get details. Please refer to the new map in the latest Directory.

Action Checklist for Recreation and Water craft Use:

- All watercraft (powered or not) must be equipped with navigation lights if operated after sunset or before sunrise.
- Operating a boat or PWC if you are under age is subject to a fine of \$100.
- Scan constantly for people, objects and other watercraft on the water.
- Be alert for conditions that limit your visibility or block your vision of others.
- As you leave or arrive at your dock with your boat or PWC, you MUST BY LAW use a 90 degree angle in order to avoid unnecessary wake (causing shoreline erosion), hitting swimmers or collision with other boats.
- Please practice BOATING sport activities as far as possible from the shoreline where the lake is wide and clear of obstructions. This will reduce, although not eliminate, the damage of wakes on our precious shores.
- Swim in designated swim safe zones (WITHIN 100 feet from shore) and boaters use extreme caution in these zones where most people swim.
- Be visible at all times while swimming. There have been reports of swimmers crossing the lake without proper accompanying spot boats or markers. This is a very dangerous situation, and we have had near misses.

#### FYI – Points of Interest

As you will already be aware, the water level this spring reached new record levels, causing considerable property and environmental damage as well. This damage could have been avoided by effecting proper dam management protocols on the Dam Lake dam, procedures which were requested from, but permanently denied by, the Municipality. Please take extra precautions with your boat wake management until our lake gets down to more normal levels. Our shorelines are already showing some devastating effects and we are losing very special old trees.

At the upcoming AGM, we will again report on recent developments in our watershed with respect to the invasive species Eurasian milfoil and measures that are being tested to control its attack on our lakes. Refer to the special report of the Milfoil Committee attached hereto.

We continue to closely follow any indications of development activities that could impact our lake and environment in any way, and regularly meet with appropriate representatives of the various authorities who have some role in this domain. Peter Kearns has a mandate to make appropriate enquiries and report regularly to the Executive and in due course to our Association members. If you are aware of any such activities that warrant further research, please advise Peter or any one of our executive whose co-ordinates are on page 8. At the AGM we will invite the Mayor to speak on the latest development activities that could impact us, as well as other matters.

We remind folks of the latest septic inspection rules and also new garbage collection and composting rules being imposed by Val-Des-Monts. Some carry significant fines for non-compliance. Details are available on our lake website or on the Municipality website as well.

We hear a number of complaints about noise and frequent fireworks, as well as broken glass, campfires and related mess at Crepin Beach. We ask that all neighbours of Crepin Beach be respectful of that beach property and of the rights of others to peaceful enjoyment of their time at the lake.

## Hiking Trail Update - June 2019



As I have reported in the last several editions of this newsletter, logging activities have played havoc with maintenance of the trail. The current approach to commercial logging using strip cutting rather than selective cuts, leaves behind considerably more large debris and ugly landscapes, not to mention ruined habitat and impassable trails. We are still in the process of reconfirming with provincial authorities the access to the crown land at the north end of Lac Grand and Lac de la Montagne for our hiking trails that was originally negotiated nearly a decade ago.

In the meantime, I am happy to report that the trail heading south and then west from the Trailhead toward Lac de la Montagne and then up to splendid views high above Lac de la Montagne and Lac Grand is in good shape and unimpeded by logging activity. The usual tidying up of winter debris – fallen branches and the occasional dead tree – is required to get the trail back to tip-top shape. That should be completed by July 1st. As the old logging road is still extremely unattractive in the aftermath of several seasons of extensive logging, an out-and-back route for this trek is recommended.

For this summer season, hikers wishing to venture up to the heights above the Culbute will find a more passable and better marked route by starting from the 'green' dock about half way along the north shore from the main Trailhead toward the Culbute. Again, fine-tuning of signage and removal of winter debris should be completed by July 1st. To get to the best look-out spots above the Culbute, follow the small road slightly downhill when you arrive at the junction of the trail and the road high up on the hill-side.

A reminder for new and long-standing users of the trail: the path is marked with white metal blazes approximately 6 cm x 20 cm fastened to trees on the right-hand side of the trail. Two parallel blazes means the trail turns in the direction of the higher blaze. A T-symbol signals the end of the trail. (Head back by the out-going route, or proceed on your own!) Revised trail maps reflecting the above will be available at the Trailhead sign-in box by end of June.

Given the amount of work required to restore those sections of our traditional trail system affected by logging, I am looking for individuals or families to volunteer to act as 'trail stewards' for designated sections of the trail. This will help spread the work around, and allow volunteers to oversee their piece of the trail at their own pace and schedules. We will still have group work parties, but trail maintenance can happen independently as well on group occasions. Please get in touch with me if you are interested in pitching in. Despite the unpleasant bouts of ecocide downloaded on to the woods, habitat and wildlife at the north end of the lake, now that the trees have leafed out and views of the carnage are blocked, our trails are once again able to provide a pleasant diversion and peaceful refuge for all of us.

#### Page 9. Cont'd for Environment

The ice went out of the lake, Spring 2019, between May 1-2. Three water samples were taken at each of the five test sites on May  $19^{th}$ ; the test results were averaged. The results (mg./ml.) were: Culbute Basin - 9.0; North Basin - 11.0; South Basin - 11.0; Southeast Basin - 11.0, and Southwest Basin - 5.0. We will test again for phosphorous in early July and September, and for fecal coliforms in early July and mid-August.

Perhaps most disconcerting is the constantly increasing spread of European milfoil. This is an invasive species which is difficult to control, but which is frequently assisted by careless human activity, most commonly, boat traffic through milfoil patches. This results in quantities of milfoil "cuttings" which are capable of drifting with currents, settling to the bottom in a new site, rooting, and spreading further in this new location. In another section of the newsletter you will read details of the activity of a dedicated group of resident volunteers who are tackling this issue head-on.

#### Interpretation

<u>Phosphorous</u> ~ while the results appear to indicate a slight decrease over last year, a review of past results does show that there have been previous peaks and valleys of equivalent magnitude. But behind occasional spikes, our 16 years of data show a clear upward trend year-over-year, which should be the focus and concern of us all.

<u>Water clarity</u> ~ while long-time residents often discuss the decrease in water clarity over many decades, the Secchi Disk results continue to be consistent with the classification OLIGOTROPHIC: "clear water with very low levels of phosphates, algae, and nutrients." This spring the Secchi readings were less than 3 m., but this is consistent with the lake spring turnover. We will repeat readings in late June.

#### The Way Forward

The direct link between human activities on a lake and phosphate increase/water clarity decrease is irrefutable. Short of Draconian measures, which would be totally unrealistic and unsupportable, there is really no action that will halt or reverse the gradual degradation of the lake without complete buy-in and cooperation of all lake residents. Simply, water quality and environmental stewardship is, and will be, the responsibility of all of us.

The three most significant contributors to this degradation are shoreline erosion, chemical runoff, and careless operation of boats.

The three most effective countermeasures to which we can all contribute are:

- 1) <u>Maintain your shoreline in the most natural state possible</u>. Native vegetation does an effective job of retaining many of the products of surface run-off, particularly phosphates and nitrates, and offers some protection against shoreline erosion.
- 2) <u>WYW</u> ~ Watch your wake. There are still a few boaters who seem completely unaware of the serious impact of their wakes on the lake shoreline. The Grand Lake Association Boating Guidelines were not formulated as an attempt to restrict fun or use of the lake; rather, they were intended to acknowledge the large increase in lake population over the years and the need to try to balance the varying uses of the lake

with a minimal impact on its ecosystems. Wakes require time and distance to expend their energy, otherwise, the full impact of that energy will be absorbed by the shoreline directly. A wake that drives hard onto shore will drag sediment back into the shallow water, causing silt to cloud the water and gradually smother the bottom. The first 10 feet of lake bottom supports almost 90% of the aquatic life in the lake. It's not rocket science to extrapolate the importance of protecting that buffer zone. If you are within 100 feet of shore, you should be travelling dead slow, and producing no wake.

<u>Try to avoid patches of weed.</u> There is more than likely milfoil within the patch and if it is cut loose, it will continue its invasion of the lake.

3) Perhaps the easiest, make "greener" decisions involve many household products (we are a long way from a municipal drainage system with sewage treatment etc.) *FYI: Cleaning Kills*: Phosphorus in detergents and shampoos end up in lake waters and many lakes in Canada are dead or dying. It is our responsibility to preserve our lake and encourage others to do so as well. Make sure *ALL* your cleaning products are phosphorous free, and that all water containing cleaning product residue gets filtered by your septic system. For example, if you operate a dishwasher, consider using an environmentally gentler brand of detergent.... same with laundry soaps. There are many other examples. Specialty shops now cater to this market niche. In most cases, the cost is comparable to "less-green" items.

#### GRAND LAKE NEWSLETTER SPRING 2019-MILFOIL UPDATE

Together we can beat the Milfoil Monster!

Last fall we told you about an invasive weed, Eurasian Milfoil, which has taken root in Grand Lake and about our efforts to contain it by installing green buoys around the lake. These green buoys mark the boundaries of the milfoil infestations, and we ask that you please respect them by going around them. We will soon have white buoys installed where even more caution is needed. These white buoys will have a sign on the top indicating that you should keep out of this area. Whether you are boating, canoeing, kayaking or swimming, please keep away from the milfoil! Any disturbance of this weed will break off pieces that can grow into a new plant.

We also wanted to let you know that over the winter we partnered with five other lakes – Dam, St.-Pierre, McGregor, McArthur and Bernard, on a coordinated milfoil information campaign. You will soon be receiving an infographic that describes this invasive weed, and gives you hints on how to stop its spread. We have included a magnet so that you can display this infographic on your fridge for your friends, family, and visitors to see. It is critical that you share this with anyone who uses your property. Also included is a letter and a map showing where the buoys are located. We will be delivering these packages to each cottage, in a biodegradable bag. Please keep an eye out for it!

We have a huge lake and with a little care we can all help stop the spread of this invasive species.
