Pierre Phillion for continuing to make his place available for our annual general meetings.

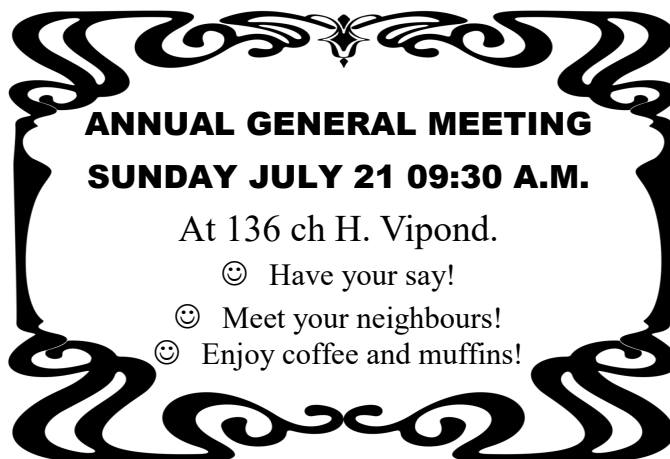
